**AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF FRANKFORD IN THE COUNTY OF SUSSEX TO AMEND CHAPTER 6, ENTITLED, "ALCOHOLIC BEVERAGE CONTROL," TO INCREASE LICENSE FEES**

**BE IT ORDAINED** by the Township Committee of the Township of Frankford, in the County of Sussex, and State of New Jersey that Chapter 6 of the Code of the Township of Frankford entitled, "Alcoholic Beverage Control," be and hereby is amended as follows:

I. §6-3.4 entitled, "License Fees," is amended to read in its entirety as follows:

The annual license fees are hereby established as follows:

Plenary Retail Consumption License:	\$825.00
Plenary Retail Distribution License:	\$825.00
Club License:	\$125.00

II. **Severability.** If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

III. **Repealer.** All Ordinances or parts of Ordinances inconsistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency.

IV. **Effective Date.** This Ordinance shall take effect after final passage, adoption and publication according to law.
