AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF FRANKFORD IN THE COUNTY OF SUSSEX TO AMEND CHAPTER 2, ARTICLE VI ENTITLED, "BOARDS, COMMITTEES AND COMMISSIONS," TO REVISE THE MEMBERSHIP OF THE ECONOMIC DEVELOPMENT COMMITTEE

BE IT ORDAINED by the Township Committee of the Township of Frankford, in the County of Sussex, and State of New Jersey that Chapter 2, Article VI of the Code of the Township of Frankford entitled, "Board, Committees and Commissions," be and hereby is amended as follows:

- **I.** §2-30.2 entitled, "Appointment of members; Terms; Meetings," is hereby amended to revise subparagraph b. to read as follows:
 - a. Committee members shall be appointed by the Township Committee. Members may be comprised of, but not limited to, Frankford residents and Frankford business owners.
- **II. Severability.** If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause of provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.
- **III. Repealer.** All Ordinances or parts of Ordinances inconsistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency.
- **IV. Effective Date.** This Ordinance shall take effect after final passage, adoption and publication according to law.
