# AN ORDINANCE TO AMEND CHAPTER 30 OF THE CODE OF THE TOWNSHIP OF FRANKFORD ENTITLED, "COMPREHENSIVE LAND USE"

**BE IT ORDAINED** by the Township Committee of the Township of Frankford, in the County of Sussex, and State of New Jersey that Chapter 30 of the Code of the Township of Frankford entitled, "Comprehensive Land Use," be and hereby is amended as follows:

### I. §30-807 14 (a).

This section is amended to increase the escrow deposits as follows:

N.J.S.A.	40:55D-70(c)	-	\$1,400	-	CHANGE
N.J.S.A.	40:55D-70(d)	-	\$1,500	-	CHANGE

This section is further amended to add a new category as follows:

Combined N.J.S.A. 40:55D-70(c) and N.J.S.A. 40:55D-70(d) on one application - \$2,000

Except as revised herein, this section shall remain unchanged.

**II. Severability.** If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause of provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**III. Repealer.** All Ordinances or parts of Ordinances inconsistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency.

**IV. Effective Date.** This Ordinance shall take effect after final passage, adoption and publication according to law.
