# AN ORDINANCE TO AMEND CHAPTER 7 OF THE CODE OF THE TOWNSHIP OF FRANKFORD ENTITLED, "TRAFFIC"

**BE IT ORDAINED** by the Township Committee of the Township of Frankford, in the County of Sussex, and State of New Jersey that Chapter 7 of the Code of the Township of Frankford entitled, "Traffic," be and hereby is amended as follows:

**I.** Chapter 7 entitled, "Traffic," is hereby amended to add a speed limit restriction for the entire length of Augusta Hill Road from U.S. Route 206 to the Hampton Township Line as follows:

#### §7.33. Speed Limits.

| Name of Street    | MPH       | Limits        |
|-------------------|-----------|---------------|
| Augusta Hill Road | 40 m.p.h. | Entire length |

- **II. Severability.** If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause of provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.
- **III. Repealer.** All Ordinances or parts of Ordinances inconsistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency.
- **IV. Effective Date.** This Ordinance shall take effect after final passage, adoption and publication according to law.
