RESOLUTION 2023-069

**REFUNDING 2023 & 2022 PROPERTY TAXES ON VARIOUS PROPERTIES
GRANTED A DISABLED VETERAN TAX EXEMPTION**

WHEREAS, Nicholas Lamonica, who is the owner of block 19, lot 24.03 located at 157 US Highway 206, was evaluated by the US Department of Veterans Affairs to be permanently and totally disabled because of injuries suffered during active duty service. The Frankford Township Tax Assessor granted a Disabled Veterans Exemption effective 17 October 2023; and

WHEREAS, John Aaron Stark, who is the owner of block 84, lot 3 located at 3 East 3rd Street, was evaluated by the US Department of Veterans Affairs to be permanently and totally disabled because of injuries suffered during active duty service. The Frankford Township Tax Assessor granted a Disabled Veterans Exemption effective 14 February 2023; and

WHEREAS, Paul Warholak, who is the owner of block 230, lot 1 located at 91 East Shore Lake Owassa Road, was evaluated by the US Department of Veterans Affairs to be permanently and totally disabled because of injuries suffered during active duty service. The Frankford Township Tax Assessor granted a Disabled Veterans Exemption effective 14 December 2022; and

WHEREAS, according to NJSA 54:4-3.30 et seq, as amended by Public Law 2019, Chapter 413 - when a veteran or a surviving spouse of a veteran or serviceperson is determined to have suffered a permanent disability being total, paraplegia, or blindness caused by their active duty service, that the applicant be granted a property tax exemption on their dwelling house and the lot where the house is erected, if they so occupy this property and it is considered their legal residence:
